During the past four decades, The Market Theatre has evolved into a cultural complex for theatre, music, dance and the allied arts. Today, The Market Theatre remains at the forefront of South African theatre, actively encouraging new works that continue to reach international stages.

Specification

We are kindly requesting quotes for Installation of new CCTV System.

Notes: There will be three cameras at Kippies building to be monitored via a wireless connection at the market theatre building. Four additional cameras will be required at the FNB building, parking area and new wiring needs to be run for the cameras. The cameras will be monitored via a wireless connection at the market square building. There will be 52 Cameras around the market theatre to strategically cover key areas on the inside and outside of the building. There will be 2 monitors. Accessibility to areas will be granted subject to prior arrangements and provided there are no shows or rehearsals going on.

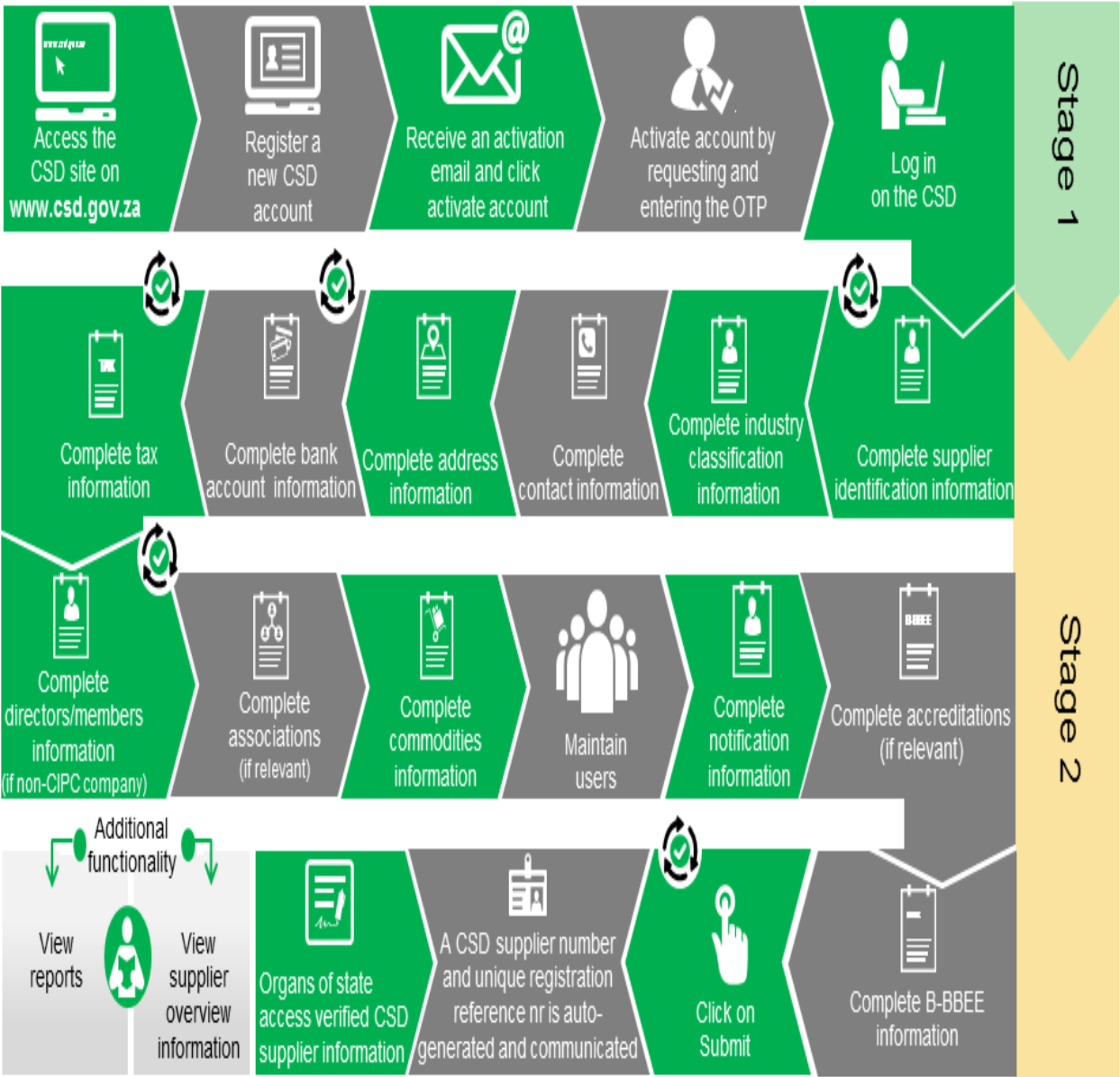
