1. INTRODUCTION:

The Market Theatre Foundation (MTF) is a Schedule 3A Public Entity in terms of the Public Finance Management Act (PFMA). The MTF is governed by the Cultural Institutions Act, as amended by the Cultural Law as Amendment Act (No 36 of 2001), and is an agency of the Department of Sport, Arts and Culture.

2. PURPOSE:

The purpose of this RFQ is to seek a service provider to facilitate a team dynamics workshop for 15 employees within the Market Photo Workshop department.

3. REQUIREMENT OF SERVICE PROVIDER:

- a) Gather information, identify and document current team dynamics, issues, and behaviors,
- b) Highlight the importance of resolving current team dynamics, issues, and behaviors,
- c) Conduct a workshop to ignite an increase in efficiency and emphasis on sharing knowledge and collaboration. Inspire communal support, team productivity, and conflict resolution techniques,
- d) Compile reports outlining the workshop's proceedings, including practical recommendations and operational tools which can be used by the team in the future.

4. FUNCTIONALITY:

An assessment of functionality will be based on the evaluation criteria below. Each evaluation criteria will carry a weighting as indicated and be bidder will be required to score a minimum of 70 points out of 100 points for functionality to qualify:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;

 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and

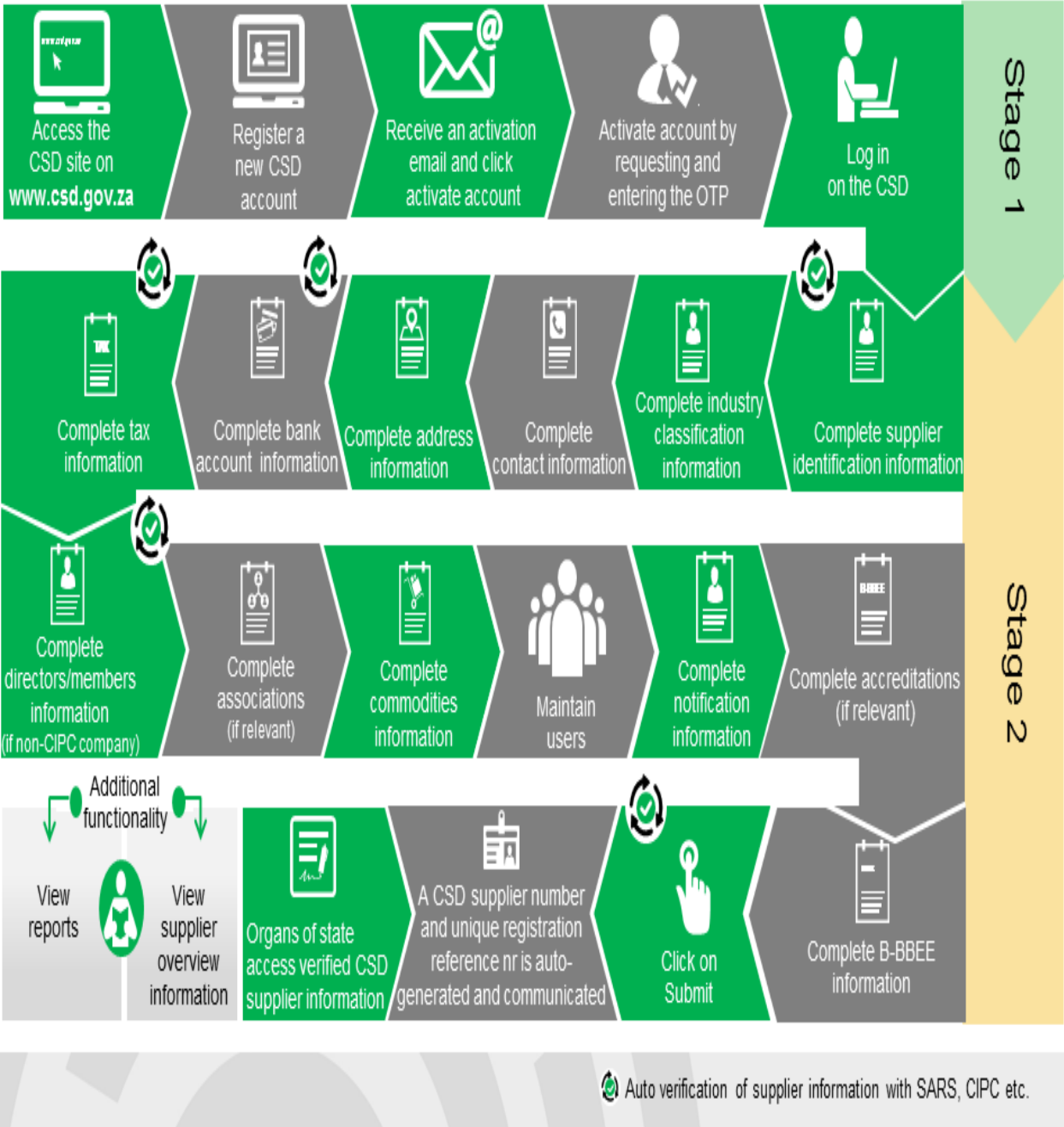
