The Market Theatre is renowned world-wide for brilliant anti-apartheid plays that have included Woza Albert, Asinamali, Bopha, Sophiatown, You Strike the Woman You Strike a Rock, Born in the RSA, Black Dog – Inj'emnyama, as well as the premieres of many of Athol Fugard's award-celebrating the past, but it is also confidently looking forward to playing a major cultural role in the 21st century for South Africa, and the African continent.

During the past four decades, The Market Theatre has evolved into a cultural complex for theatre, music, dance and the allied arts. Today, The Market Theatre remains at the forefront of South African theatre, actively encouraging new works that continue to reach international stages.

#### **Specification.**

The Market Theatre Foundation is looking for a potential bar operator/ supplier to operate the MTF bar for 2 months.

#### **Background**

The Market Theatre is in a tender process of appointing a wholesaler to supply stock to the MTF bar over a 3-year period.

We require a potential bar operator/ supplier to fill in until the process has been finalised.

#### **The potential bar operator/ supplier will be responsible for the following.**

1. Take over the bar operations for a 2-month period.
2. Supply stock to the Bar for the 2 months period.
3. The potential bar operator/ supplier will operate under the MTF's liquor license.
4. A condition will be that the MTF will take a percentage of the profit for the 2 months. This percentage is determined by the potential bar operator/ supplier.
5. The Market Theatre will evaluate the proposals, and the highest offer will be considered.
6. The company will be operating under the MTF Brand.
7. There is 3 Barman operating the Bar so the potential bar operator/ supplier may absorb them for the 2 months or bring in their own bar tenders.
8. The Bar is operating on the moment so there is a set selling price on the stock, we would like if the potential bar operator/ supplier can keep his pricing the same.
9. The Bar area has seating, stock storage space and under counter fridges.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
  - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
