The Market Theatre Foundation is looking for a catering company to cater for an fundraising event on 13 November 2025

The Market Theatre is renowned world-wide for brilliant anti-apartheid plays that have included *Woza Albert*, *Asinamali*, *Bopha*, *Sophiatown*, *You Strike the Woman You Strike a Rock*, *Born in the RSA*, *Black Dog – Inj'emnyama*, as well as the premieres of many of Athol Fugard's award-celebrating the past, but it is also confidently looking forward to playing a major cultural role in the 21st century for South Africa, and the African continent.

During the past four decades, The Market Theatre has evolved into a cultural complex for theatre, music, dance and the allied arts. Today, The Market Theatre remains at the forefront of South African theatre, actively encouraging new works that continue to reach international stages.

Specification.

The Market Theatre Foundation is looking for a catering company to cater for a fundraising event on 13 November 2025.

The company will be responsible for supplying the following:

- Full service caterer to provide food, catering equipment, waitrons, eating utensils, glasses, serviettes etc for a high-end event starting at 18h00 and ending at 19h45 at Gramadoelas at the Market Theatre in Newtown.
- Caterer must provide a hot meal consisting of both meat and vegetarian options as a series of small plates – eg small bowl of beef stew, tacos, veg skewers, sliders etc
- Food can be served on platters with circulating waitrons, or at 3-4 different stations around the venue – either way to prevent long queues/waiting for food.
- Food and drink services must not disrupt the speakers/performers at the event who will be speaking between 18h30 and 19h30
- There is a bar in the venue and a small en-suite kitchen that can be used for final preparation/warming of food but not for cooking.
- Small amount of décor – flowers for tables but not tablecloths.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

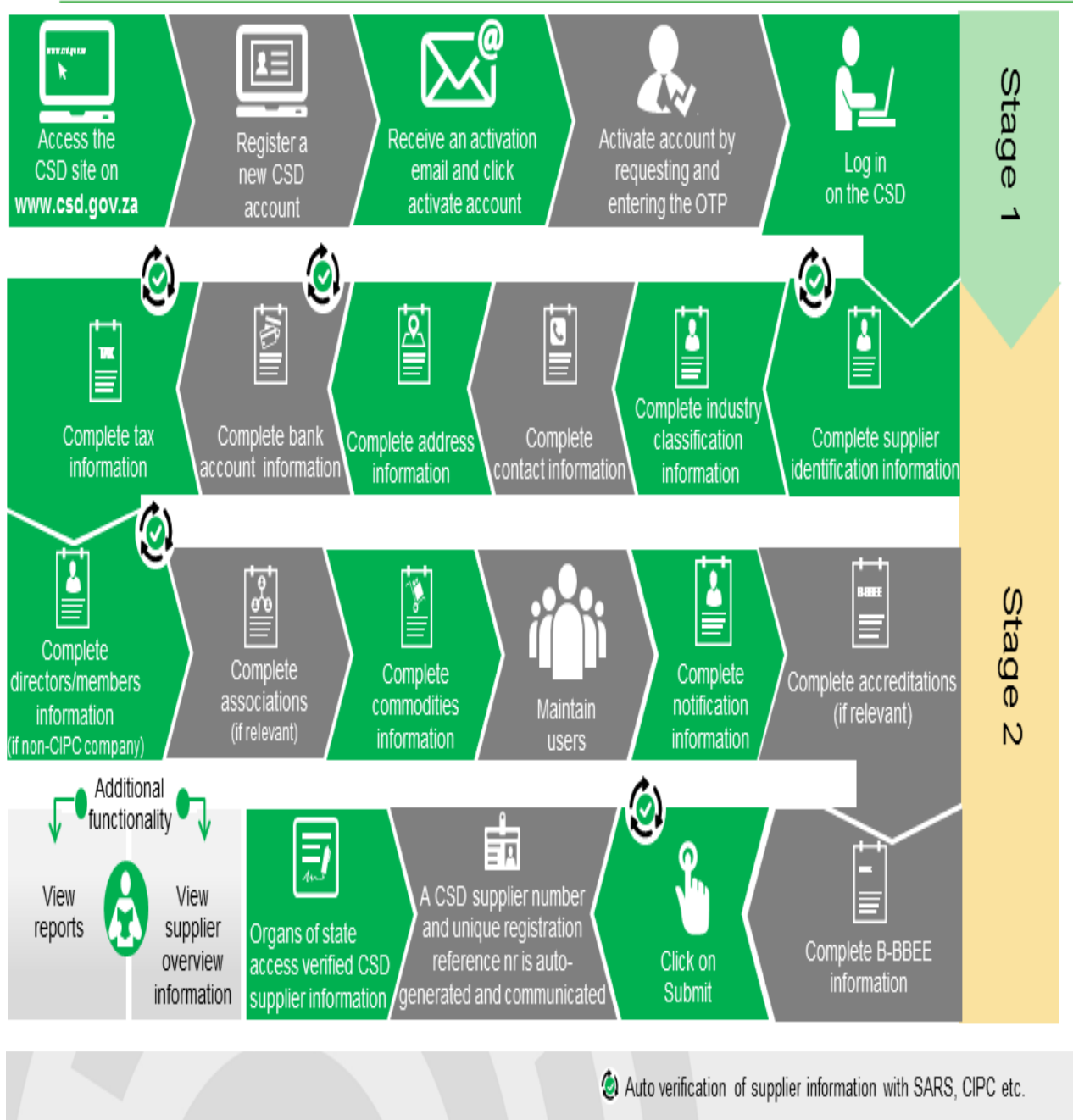
