The Market Theatre is renowned world-wide for brilliant anti-apartheid plays that have included Woza Albert, Asinamali, Bopha, Sophiatown, You Strike the Woman You Strike a Rock, Born in the RSA, Black Dog – Inj'emnyama, as well as the premieres of many of Athol Fugard's award-celebrating the past, but it is also confidently looking forward to playing a major cultural role in the 21st century for South Africa, and the African continent.

During the past four decades, The Market Theatre has evolved into a cultural complex for theatre, music, dance and the allied arts. Today, The Market Theatre remains at the forefront of South African theatre, actively encouraging new works that continue to reach international stages.

#### **Specification.**

The Market Theatre Foundation is looking for wholesaler to supply and deliver diesel for the Market Theatre Foundation generators.

The Service provider will be responsible for the following functions:

1. The Market Theatre Foundation Facilities department will request a delivery of diesel from the preferred service provider on a as and when required basis.
2. The service provider needs to deliver the diesel within 24 hrs of the order request.
3. The diesel supplier must deliver the diesel in a vehicle or trailer that complies with all the health and safety protocols that is required.
4. The Market Theatre Foundation may request a diesel testing sample certificate of the diesel being supplied to assure the quality is correct.
5. The Preferred diesel supplier must be in the possession of a wholesale license from the Department of Mineral Resources and Energy which allows to buy petroleum products in bulk (1 500 liter's or more, per transaction of petroleum products) from a licensed manufacturer, and to sell it to end users.
6. The Market Theatre will not pay for diesel upfront. Payments will be done once a invoice is submitted after delivery has been made within 30 days.

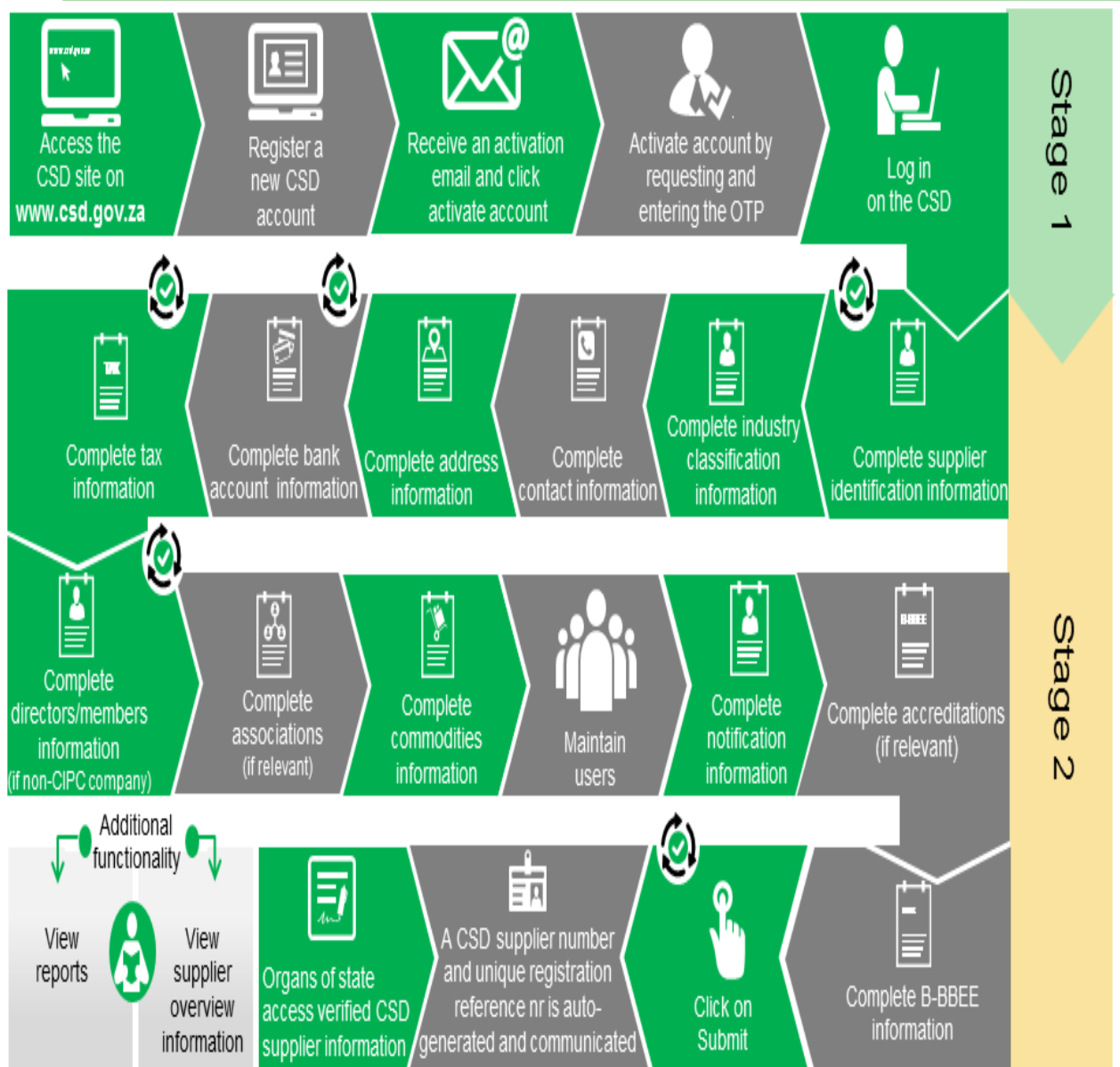
