The Market Theatre Foundation (MTF), a Schedule 3A Public Entity governed by the Cultural Institutions Act and an agency of the Department of Sport, Arts and Culture, seeks to appoint a qualified service provider to conduct comprehensive background checks for five (5) recruitment positions.

PURPOSE

To ensure the integrity and suitability of candidates, MTF requires background verification services that include identity, criminal, reference, and qualification checks and psychometric assessments.

SCOPE OF WORK

The selected service provider will be expected to perform the following checks and psychometric Assessments for each of the five (5) candidates:

1. **Identity Verification**
 - Validation of South African ID documents.
2. **Criminal Record Check**
 - SAPS clearance.
3. **Reference Checks**
 - Contact and verify **three references per candidate**.
 - Provide a summary of feedback received.
4. **Qualification Verification**
 - Validate academic qualifications.

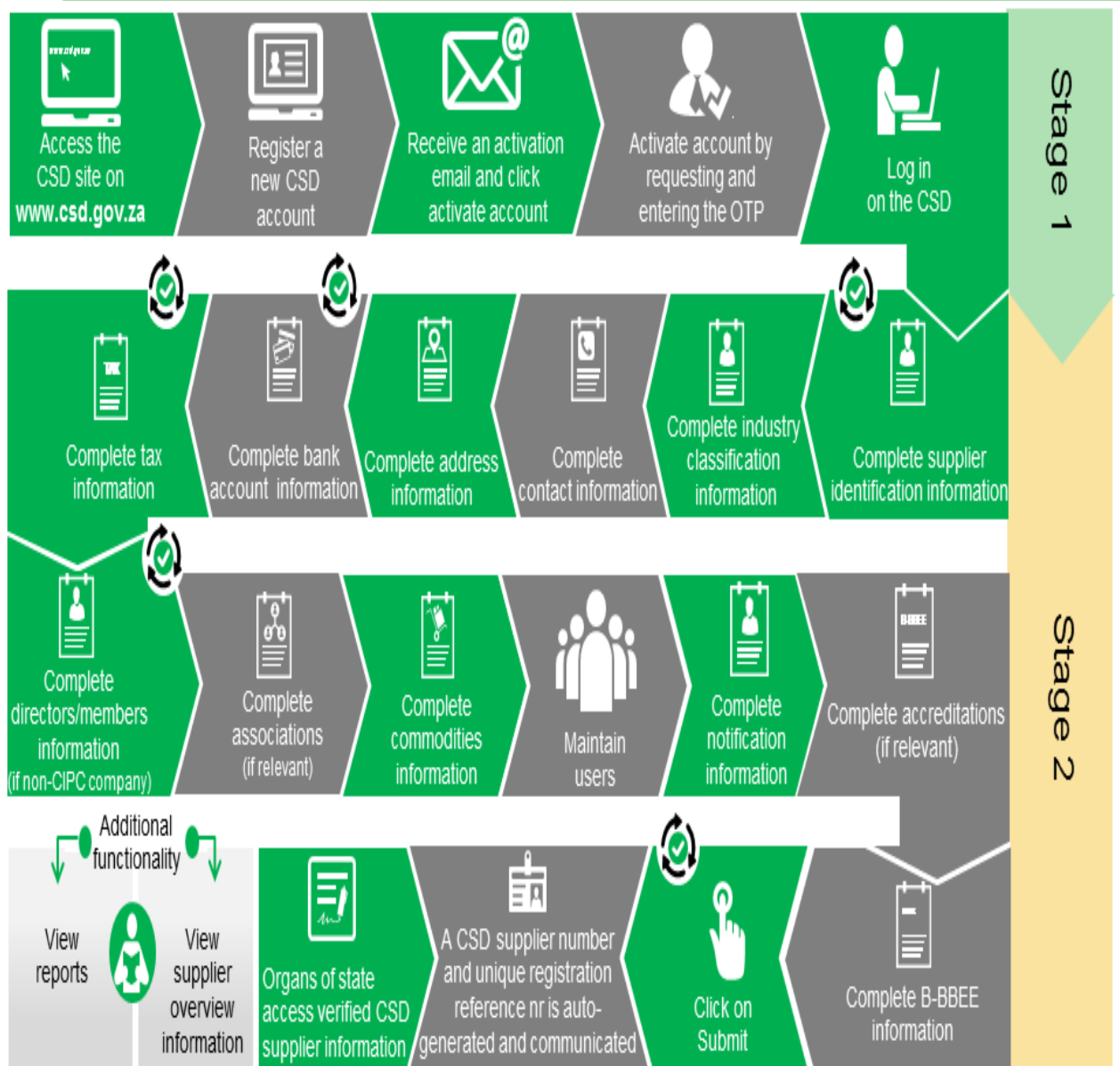
